It is notified, that development charges for water @ Rs. 55/-per sq.m of the plotted area plus 12% simple interest w.e.f. 01-08-1999 will be levied from those consumers who had not deposited the advance payment of water development charges upto 30-09-2000.

The plot-holders/occupiers are advised to apply for sanction of water connection in the prescribed form which may be obtained from the office of **Zonal Revenue Officer(NW)I**, **Jalebi Chowk**, **Sultanpuri**, **Delhi**. The form can also be down-loaded from DJB's website www.delhijalboard.nic.in. After sanction of water connection and payment of initial charges, water development charges and road restoration charges, the applicant shall be allowed to obtain boring permission and executing the work at his level by engaging a licensed plumber. The onus will be on the plot holders to get the bills from above office of DJB for development charges to be paid.
