**PUBLIC NOTICE**

Notice is hereby given in pursuance of section 9(1) (a) of the Delhi Water Board Act 1998 that in the area of state of Delhi as specified in the Schedule below, water is available from the water source of the Board for reasonable supply to all the lands and buildings in such area.

It is notified, that development charges for water @ Rs. 55/-per sq.m of the plotted area plus 12% simple interest w.e.f. 01-08-1999 will be levied from those consumers who had not deposited the advance payment of water development charges upto 30-09-2000.

However, those residents who had paid whole amount on or before 30-09-2000 after taking rebate, as per the letter dated 30-7-1999 of Executive Engineer (RWS) North are exempted from payment under present notification but they are required to produce the original G-8 i.e. the receipt of payment made by them.

The plot-holders/occupiers are advised to apply for sanction of water connection in the prescribed form which may be obtained from the office of **Zonal Revenue Officer(NW)I, Jalebi Chowk, Sultanpuri, Delhi**. The form can also be down-loaded from DJB's website [www.delhijalboard.nic.in](http://www.delhijalboard.nic.in). After sanction of water connection and payment of initial charges, water development charges and road restoration charges, the applicant shall be allowed to obtain boring permission and executing the work at his level by engaging a licensed plumber. The onus will be on the plot holders to get the bills from above office of DJB for development charges to be paid.
