**PUBLIC NOTICE**

In pursuance of the provision of section 32 of the Delhi Water Board Act, 1998, it is notified for general information of the public that in the Territorial area of Delhi specified in the schedules given below, the internal sewerage system has been completed and made functional for collection, removal and disposal of all the filth, polluted and obnoxious matter from latrines, urinals and cesspools. It does not include any industrial effluent or any other discharge prohibited under law.

Plot holders are requested to pay only initial charges for new sewer connection such as opening Fee and RR charges as fixed from time to time. Infrastructure Charges on plot size above 200 sqm, as per applicable norms is payable.

Extension of house service connection by DJB through separate tender is also in process, but citizens are allowed to avail house service connection on their own as per process given below:

The plot-holders/occupiers are advised to apply for sanction of sewer connection online on DJB Customer Portal [www.djb.gov.in](http://www.djb.gov.in) or assistance of mobile Sahayak may be taken by calling '1076' under Door Step Delivery Of Public Services. After sanction of sewer connection and payment of initial charges for sewer connection, consumer may execute the work through licensed plumber. The onus will be on the plot-holders to get the bills from ZRO office of DJB.

As obtaining sewerage connection is mandatory for every Household, after this notification. DJB will levy sewerage charges as per tariff irrespective of the fact sewerage connection is taken by residents or not.
