**Public Notice**

**For Kind Attention to Owners of Water Tanker Vehicles**

A public notice was published on 14.12.2013, inviting applications for registration of water tanker vehicles in Delhi Jal Board within 30 days, which was extended up to 27.01.2014. Last date of receipt of applications is now further extended to 31.03.2014. Application format is available on DJB website [www.delhijalboard.nic.in](http://www.delhijalboard.nic.in) (Home>information>news>S. No. 106 Authorization/Registration of water tanker vehicles in DJB).

Owners of Water Tanker Vehicles supplying water in the NCT of Delhi, in the areas not falling under the jurisdiction fee of Rs. 1000/- per water tanker vehicle to EE (RWH/GW Cell), DJB, Room No.-11, Varunalaya Phase-I, Karol Bagh, New Delhi-110005 along with attested copies of the following documents for registration of water tanker vehicles;

1. Registration, fitness and pollution under control certificate of the vehicles.
2. Valid permit for plying of the vehicles in NCT of Delhi for non-Delhi registered vehicles.
3. Documents regarding hiring of water tanker vehicles and delivery point from the recipient of water.
4. Document in support of permission for filling water tanker from the authorized owners of the water sources mentioned in the application.

Authorized owners of the water sources means government owned water sources, water sources approved by the Competent Authority i.e. Delhi Jal Board/ Central Ground Water Authority/ "Authority Officer" i.e. Deputy Commissioner (Revenue) concerned for the purpose of supplying water through water tanker vehicles. The application of the water tankers that are being hired/ utilized by the Govt. Agencies i.e. CPWD, DDA etc shall be considered in light of an NOC regarding sources of water as submitted by Govt. Agencies. Quality of water as per drinking water standard IS: 10500:2012 supplied to water tanker vehicles registered for transporting potable water shall be ensured by the respective authorized owner of the water source. This standard shall not apply to non-potable water supplied to water tanker vehicles registered for transporting such water.

Applications without the requisite documents/ incomplete applications will be summarily rejected.
