A Meeting was held in the chamber of CE(C&N) on 10.6.15 at 12:00 noon with MLA karol bagh, Sh. Vishesh Ravi to discuss various problems/issues in his constituency.

Following issues were discussed:-

1. MLA raised for a inter connection of T/well water to augment supply of water in **Tola Wali Gali**. It was told by field staff i.e. Sh. Akbar Khan, ZE & Sh. Harish, jE(Sh. Prem pal, ZE was on leave) that it was tried to interconnect on 8.6.15 but the same could not be carried out due to public resentment. It was directed by C.E.(C&N) that the work should be carried out and if needed police force may be obtained. It was emphasized upon by C.E.(C&N)that work should be done by 12th of june and it must be ensured.

Ramjain Mandir wali Gali.

In this regard it was raised by MLA that for augumentation of tube well water, connections from other nearby T/wells may also be done. Concerned Z.E & J.E. reported that due to public hindrance it could not be done earlier. Mater was also reported to MLA. MLA also communicated let this work stop immediately and take up after some time. S.E.(Central) directed to make video graphy of public resistance.

- 3. MLA further raised that regarding release of MLA fund in MLAD fund. Letter has been issued from U.D. Deptt. Same has been released to DJB.He further added when MLA fund will be received short notice tenders should be called for which C.E.(C&N) agreed. Said proposal may be approved from C.E.(C&N). C.E.(C&N) directed to undersigned to meet in person to Jt. Dir(F&A)II and analyze the budget position of MLA fund and DJB fund also for which undersigned committed to ensure.
- 4. MLA further raised that water supply timings are different available on DJB website and physical. He further added that CCTV camera should be fixed at Ramjas tank to monitor the accessibility of individual under Ramjas tank. C.E.(C&N) and S.E.(Central) directed to E&M staff to get it install for one month on trail basis.
- 5. MLA further raised tube well running in Bapa Nagar tank Dev Nagar area are being run by private persons and they should be atomized. MLA further raised to atomize one tube well immediately, for this E&M staff agreed.

The meeting ended with vote of thanks to chair.
