	C Block, Vikas Puri (Sewer)	
	Sa. B.R Bhakri from RWA, raised the question of dealting of sewer line of area.	The desilting of main sewerfine will be done mechanically for which estimate have aiready been framed & the cleaning of branch sewer will be done as and when required.
2	C Block, Vikas Puri (Water)	
	RWA raised the issue about the water line from C-480 to 498 are very old and required replacement.	Sh. Sunil Kumar J.E told that the water times of this area will be checked & work of replacement will be done if required as per feasibility.
	RWA raised the issue regarding supply of water in the evening for 15 to 20 minutes with low pressure only.	The pumping hours from Budhella BPS in evening is only for 1 hour i.e. 5:30 to 6:30 pm resulting low pressure in tail end areas.
	RWA raised the objection regarding filling of water tankers from Budhella BPS filling point.

	RWA requested to place Drop boxes for receipt of cheque for water bill payment in RWA office.	Regarding placing drop boxes at RWA office it was told that this practice has been stopped and efforts will be made to revive the same.
