**NOTIFICATION**

No.16(512)/UD/W/2015/ The following Recruitment Regulations made by the Delhi Water Board under clause(m) sub-section (2) of section 109 read with sections 7 and 51 of the Delhi Water Board Act, 1998 (Delhi Act. No. 4 of 1998) approved vide Competent Authority orders dated the 27<sup>th</sup> February, 2015 and concurred by the Union Public Service Commission vide their letter F. No. 3/24(14)/2015-RR dated 3<sup>rd</sup> June, 2015 and in supersession of the Draftsman Grade-II recruitment and promotion regulations notified vide notification No. F9/40/80-LSG/8656 dated the 31<sup>st</sup> December, 1980, except as respects things done or omitted to be done before such supersession, regarding method of recruitment to the post of Draftsman Grade-II in the Delhi Water Board, Delhi are hereby published, namely:-

1. **Short title and commencement** - These regulations may be called the Draftsman Grade-II in Delhi Jal Board Recruitment and promotion Regulation, 2015.
2. **Number of posts, Classification and pay band and grade pay/scale of pay** - The number of posts, their classification and pay band and grade Pay/scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these regulations.
3. **Method of recruitment, age limit and other qualifications** -The method of recruitment, age limit, qualifications and other matters relating to the said post, shall be as specified in columns 5 to 13 of the said Schedule.
4. **Disqualifications** - No person,
  - (a) Who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) Who having a spouse living, has entered into or contracted a marriage with any person,

5. **Power to relax** - Where the Government of National Capital Territory of Delhi is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. **Saving** - Nothing in these regulations shall affect reservations and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes and other special categories of persons in accordance with orders issued by the Central Government from time to time in this regard.

 Note: The qualification(s) regarding experience is/are relaxable at the discretion of the competent authority, for reasons to be recorded in writing in the case of candidates belonging to Scheduled castes or Scheduled tribes if at any stage of selection the competent authority, is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancies reserved for them.

11. service for promotion, the service rendered on a regular basis by an officer prior to 1<sup>st</sup> January, 2005 the date from which the revised pay structure based on the 6<sup>th</sup> CPC shall be deemed to be service rendered in the corresponding pay/pay scale extended based on the recommendations of the commission, of the pay

Deputation:-  
 Officers under the Central/State Governments/UTS

(A)(i) Holding analogous post on regular basis in the parent cadre/ department; or

(ii) With six years service in the grade rendered after appointment thereto on a regular basis in PB-1 Rs. 5200-20200/- with Grade pay of Rs. 2800/- or equivalent in the parent cadre/department; or

(iii) With Ten years' service in the grade rendered after appointment thereto on a regular basis in PB-1 Rs. 5200-20200/- with grade pay of Rs. 2400/- or equivalent in the parent cadre/department; and

(B) Possessing the educational qualifications and experience prescribed for direct recruits under column 7.

Note 1: The departmental officers in the leader category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
