National Mission for Clean Ganga (NMCG), Ministry of Water Resources, Ganga Rejuvenation and River Development, Government of India (GOI), has received a loan from Japan International Cooperation Agency (JICA) towards, the cost of Yamuna Action Plan Project (III); It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for **“Providing and Laying Rising/Pressure Mains of 700-900 mm dia. DI Pipes at Various Locations in Kondli WWTP Catchment Area Under YAP-III (Package K4)”**.
2. The Delhi Jal Board now re-invites sealed Bids from experienced and eligible Bidders for **“Providing and Laying Rising/Pressure Mains of 700-900 mm dia. DI Pipes at Various Locations in Kondli WWTP Catchment Area Under YAP-III (Package K4)”**.

Bidding will be conducted through the international competitive bidding procedures specified in the Guide lines for Procurement under JICA-ODA Loans, and are open to bidders from eligible source countries as defined in the loan agreement. **A Single Stage, Three-Envelope, bidding procedure will be adopted. Bidders are to submit simultaneously three sealed envelopes, one containing the “initial filter” for pre-qualification, second containing Technical proposals and third containing the Price proposal. First only initial filter shall be opened and Technical Proposal of only those bidders will be evaluated who meets the eligibility criteria as annexed.**
