PUBLIC NOTICE

It is notified for information of the General Public that as per the provision of Section 135 B(1) of the Representation of People Act 1951, every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote, shall be granted a holiday on 04.12.2013, the day of Poll in Delhi, so that he/ she can cast his/ her vote at election to the Delhi Legislative Assembly.

As per sub-section 2 of Section 135 B of the Representation of People Act 1951, No deduction or abatement of the wages shall be made on account of above holiday and if any person is employed on the basis that he/ she would not ordinarily receive wages for such a day, he/ she shall nonetheless be paid wages he/ she would have drawn had not a holiday been granted to him/ her on that day.

Any contravention of the above provisions is punishable as per the Provisions of section 135 B (3) of the Representation of People Act, 1951.

However, as per Sub-section 4 of section 135 B of the Representation of the People Act 1951, this section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged.

It is further brought to the notice of all concerned that Election Commission of India vide letter No. 78/2013/EPS dated 24.10.2013 has clarified that there may be cases where a person is ordinarily resident of the constituency and registered as an elector, may be serving/ employed in an industrial undertaking or an establishment located outside the constituency having a general/ bye-election, in such a situation even those elector including casual worker working outside the constituency concerned would be entitled to the benefit of a paid holiday extended under section 135 B (1) of the Representation of People Act, 1951. The daily wage /casual worker are also entitled for a holiday and wages on whole day.
