### **Press Note**

Due to less receipt of raw water in Delhi Sub Branch (DSB), Carrier Line Channel (CLC) and reduction of pond level i.e. 666.80 ft. against the normal level of 674.50 ft. in River Yamuna at Wazirabad, the water production has been affected adversely in Chandrawal and Wazirabad Water Treatment Plants. Delhi Jal Board has done rationalization of water in whole Delhi. Therefore, water supply will be available at low pressure in the morning and evening of 30.06.2022 and so on till the sufficient water is released by Haryana in DSB, CLC and in River Yamuna

The areas likely to be affected are Civil lines, Hindu Rao Hospital and adjoining areas, Kamla Nagar, Shakti Nagar and adjoining areas, Karol Bagh, Pahar Ganj and NDMC areas, Old & New Rajinder Nagar, Patel Nagar (East & West), Baljeet Nagar, Prem Nagar, Inderpuri and adjoining areas, Kalkaji, Govindpuri, Tugalkabad, Sangam Vihar, Ambedkar Nagar, Prahladpur and adjoining area, Ramleela Ground, Delhi gate, Subhash Park, Model Town, Gulabi Bagh, Punjabi Bagh, Jahangirpuri, Moolchand, South Extn., Greater kailash, Burari and adjoining areas, Parts of Cantonment areas and South Delhi.

Therefore, public is advised to make judicious use of water and water tankers shall be available on demand from following water emergencies:
